You are welcome to set up as early as WEDNESDAY evening. Specific time frames will be provided as the event gets closer. The room will also be open as early as 6:30am on Thursday for set up but you are welcome to set up anytime up until the cocktail reception at 5pm. Key times you can be set up for are Attendee registration (7AM-8AM), designated breaks and lunch (12PM-1PM) both Thursday and Friday. The main event for Exhibitors is the **Cocktail Reception** which takes place Thursday evening from **5:00PM to 7:00PM**. You can either tear down following the reception Thursday or stay up through lunch on Friday but you are required to be out of the room by 1:30PM Friday. Full schedule with designated breaks will be provided. **Please circle or highlight on the registration if you plan to attend breakfast and lunch so we can have an accurate count for food.**

Confirmation will be sent upon receipt of your payment. **Exhibit table placement in the hall is based upon the date your payment is received** so register early for prime locations. We have included a line for you to inform us of your key competitors that you would prefer not to be located by and we will do our best to work around those. Once you arrive, if you have any concerns about your location based on who is next to you please let us know as soon as possible and we will do our best to relocate you.
